He was previously, inter alia, ambassador to France 2014-2019 and Director General of Legal Affairs at the Norwegian Ministry of Foreign Affairs 2002-2014. Ambassador Fife was also chief negotiator of Norway for the maritime delimitation with the Russian Federation in the Barents Sea and the Arctic Ocean.

He has been a member of the Committee for Gender Balance and Diversity in Research and he received the Gender Equality Award at NTNU in 2009.

In the field of transport and mobility, she was Director of Land Transport, responsible for road and rail transport in the EU and its security. In March 2021, Ms. Werner was appointed Deputy Secretary-General of the European Commission. She is responsible for policy coordination, including the Green Deal. She is also Chair of the EC's Taskforce on Equality. Ms. Werner holds a degree from the University of Vienna in economics and a MA from Collège d'Europe, Bruges.

Dr Christian Ehler has been a Member of the European Parliament since 2004 and has been a Member of the Committee on Industry, Research and Energy for over ten years. Furthermore, Dr Ehler is Chair of the Parliament's think tank, the STOA (Science and Technology Options Assessment) Panel.

Over the last four-year period, he served as a Lead Author on working group three of the intergovernmental panel on climate change.
