

AUTHORS' RESPONSIBILITIES

By submitting a manuscript for consideration for presentation at the *33rd International Conference for Electrical Contacts*, to be held in Trondheim from June 21-25, 2026, and for publication in the Conference Proceedings, the author agrees to the following:

- The manuscript will undergo peer review prior to acceptance for publication.
- At least one author or co-author must register as a participant before 15 April 2026, attend the ICEC2026, and present the paper in person if accepted.
- Each paper must have at least one registered author or co-author attending the conference.
- The manuscript must comply with the *Instructions for Authors* available at www.icec2026.com, including using the manuscript template, avoiding commercial content and not exceeding six pages in length.

PUBLICATION AGREEMENT

By submitting a manuscript for publication in the *Proceedings of the 33rd International Conference for Electrical Contacts*. Part of the *SINTEF Proceedings* series (ISSN 2387-4295), the author hereby:

1. WARRANTS that the manuscript or poster is an original work, not previously published and not submitted to any other publisher in the present form; that the author is the sole proprietor of all rights in the work; and that the work does not contain any libelous or unlawful statements, and does not infringe on the rights of others;
2. AGREES to indemnify and keep effectually indemnified SINTEF from and against all actions, proceedings, costs, damages, claims, demands, expenses, loss and liability whatsoever arising out of any breach of the warranty given in Clause 1;
3. TRANSFERS to SINTEF the exclusive rights comprised in the copyright of the work including the right to be:
 - printed in the conference proceedings
 - reproduced and distributed (publishing law)
 - published electronically as well as the editing, storage on electronic data carriers required herefor, download and availability in an on-line database.
 - used in presentations, the layout of the conference proceedings and the promotion for the conference proceedings.

All this on the understanding that the author may, without further permission:

- use all or part of the work in any subsequent book or academic journal article written by an author;
 - archive the published version in the electronic repository of the institution (university or research) in which the author is an employee or research student after publication of the manuscript;
 - make any numbers of copies of the work for circulation among professional colleagues of the author; and
 - make any numbers of copies of all or part of the work for use by the author in teaching.
