### **Knowledge Outputs: Aquanis KO**

**CETMAR** is currently exploring two different pathways to transfer the <u>AquaNIS KO</u> (Online Information System on Aquatic Non-indigenous and Cryptogenic Species). It is also currently collaborating with the Spanish Oceanographic Institute on KOs concerning Underwater Noise.

### **COLUMBUS** Brokerage Event: Guidelines Presentation of the Jerico-Next project, Southampton (UNITED-KINGDOM)

**EuroGOOS** held on April 4th at the industry brokerage event a workshop on the "Jerico-Next" project. It provided an opportunity for marine observation data's end-users to share feedback with the coastal observatories managers on both the relevance and the impact of different data sets used for business activities. A set of newly produced guidelines was also presented. Based upon the results of meetings run at the October SeaTech week and from one-to-one meetings with the industry, these guidelines highlight best practices and challenges to consider when engaging with industry.



**Monitoring** Observation and Guidelines Publication has been prepared by Seascape, VLIZ, EuroGOOS, Marine South East, **SmartBay Ireland** in order & encourage marine data sharing and re-usage by industry members. They provide an analysis of both barriers and bottlenecks limiting marine data sharing and re-usage by industry members, and set some recommendations.
